## Key Considerations

- SSC will work closely with Interpodia to hide references to historical data within IceReg regarding a registrant's sex at birth.
- Data collected via IceReg regarding a registrant's gender identity shall be made available by default within all SSC-level reports, PTSO-level reports, club-level reports, and event reports. Note data partitioning rules shall still apply.
- The standardized question regarding a registrant's sex at birth (male, female, unspecified) shall be removed from the membership registration process in IceReg and will not be re-added for PTSOs and clubs. Note questions regarding a registrant's sex at birth may be added within an organization's event registration process, per SSC's [Equity, Diversity, and Inclusion Policy](#).
